

## CORTEVA RANGE AND PASTURE KEEP STEWARD GIVEAWAY

### OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION DESCRIPTION:** The **Corteva Range and Pasture Keep Steward Giveaway** (“Sweepstakes”) is open to individuals who are cattle producers or otherwise work in the pasture and land management industry as of 3/15/23 and receive the direct mail Sweepstakes invitation from Corteva Agriscience (“Sponsor”). The Sweepstakes begins 3/15/23 at 12:00:00 AM Central Time (“CT”) and ends 5/15/23 at 11:59:59 PM (CT) (“Promotion Period”).
2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry; are the intended recipient of the Sweepstakes invitation from the Sponsor; and are a cattle producer or otherwise work in the pasture and land management industry as of 3/15/23. Employees of Corteva Agriscience, its parent company, subsidiaries, affiliates, advertising, promotion and other agencies (“Promotion Entities”) and their families and/or those living in the same household of each are not eligible. Void where prohibited.
3. **HOW TO ENTER:** During the Promotion Period, eligible individuals who receive the direct mail Sweepstakes invitation will go to [KeepSteward.com](http://KeepSteward.com) (“Website”) and follow the instructions to complete the online entry form to enter the Sweepstakes. Once at the Website, they must follow the instructions to complete the online entry form and enter the Sweepstakes. As part of the entry process, entrants must opt in to receive communications from Corteva Range & Pasture. Sweepstakes registration and entry is free. Online entry must be completed by 11:59:59 PM (CT) on 5/15/23.

No automated entry devices, bots and/or other programs and/or software are permitted for Sweepstakes entry. All entries become the sole property of the Sponsor and will not be returned. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic. Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of entries in the Sweepstakes.
