

UTRISHA™ N TRAINING SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION.** The **Utrisha™ N Training Sweepstakes** (the “**Sweepstakes**”) is open only to eligible retailers of **Corteva Agriscience** products and begins 11/1/21 at 12:00:00 AM (CT) and ends 12/15/21 at 11:59:59 PM (CT) (“Promotion Period”). At the conclusion of the Promotion Period, five (5) prizewinners will be randomly selected by Corteva Agriscience (“Sponsor”) or its designee, from all eligible entries received during the Promotion Period, as further described below. Entry into the Sweepstakes is free.
2. **HOW TO ENTER:** During the Promotion Period, eligible **Utrisha™ N** retailers in the forty-eight (48) contiguous United States and District of Columbia (excludes Alaska and Hawaii) will click on the link in their email invitation or will go online to <https://indd.adobe.com/view/da01be5e-9132-411e-a028-63a542d4412d>
3. (“Website”) and follow the on-screen instructions to complete their registration and the product-level training on Utrisha™ N nutrient efficiency optimizer to enter the Sweepstakes. Upon completion of their training, entrants must complete and submit an official training completion form, including their name and email address, in order to enter the Sweepstakes. Eligible retailers must complete the training within 30-days of starting the training; last day to complete training is 12/15/21.
Limit one (1) entry per person/email address in the Sweepstakes. In the event of a dispute regarding the identity of an online entrant, any online entries will be deemed to have been submitted by the Authorized Account Holder of the email address submitted at the time of entry, provided that person meets all eligibility requirements set forth in these Official Rules. “Authorized Account Holder” means the natural person who is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entrants may not participate with multiple e-mail addresses, nor may entrants use any device or artifice to enter multiple times or as multiple entrants. Any entrant who attempts to enter with multiple e-mail addresses, under multiple identities or uses any other device or artifice to enter multiple times will be disqualified from participation in the Sweepstakes and all entries submitted by that entrant will be void. Sponsor is not responsible for lost, late, misdirected, incomplete, delayed or undeliverable entries. Sponsor is not responsible for any change to email address, mailing address and/or telephone number of entrants.
4. **ELIGIBILITY:** Open to legal residents of the forty-eight (48) contiguous United States and District of Columbia (excludes Alaska and Hawaii) who are 18 years of age or older at time of entry and are a Corteva Agriscience™ retailer. Employees of Corteva Agriscience, its parent company, subsidiaries, affiliates, advertising and promotion agencies (“Promotion Entities”) and immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply.

5. RANDOM DRAWING: Five (5) prizewinners will be selected in a random drawing on or about 12/17/21 from among all eligible entries received during the Promotion Period by the Sponsor or its designee.
6. WINNER NOTIFICATION: Potential prizewinners will be notified by email at Sponsor's discretion, within five (5) days of the completion of the drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any prize-winner notification that is lost, intercepted or not received by the potential prize-winner for any reason.
