

TRUCHOICE® SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION.** The **TruChoice® Sweepstakes** (the “**Sweepstakes**”) is open only to farmers in the states of eligibility (see rule #2). Sweepstakes begins at 12:00:00 AM (CT) on 10/6/22 and ends at 11:59:59 PM (CT) on 1/31/23 (“**Promotion Period**”); and consists of a Grand Prize Sweepstakes (the “**Grand Prize Sweepstakes**”) and a Weekly Sweepstakes (the “**Weekly Sweepstakes**”). The Weekly Sweepstakes will consist of seventeen (17) Weekly Entry Periods (collectively, the “**Weekly Entry Periods**”) during the Promotion Period. For purposes of these Official Rules, a “week” is defined as a seven (7) calendar day period during the Promotion Period beginning on a Thursday at 12:00:00 AM (CT) and ending seven (7) days later on a Wednesday at 11:59:59 PM (CT) (except the last week of the Sweepstakes that covers an six (6) day period starting on a Thursday and ending six (6) days later on a Tuesday). **Nonwinning Weekly Sweepstakes entries will be automatically rolled over into subsequent Weekly Sweepstakes drawings. Additionally, all eligible Weekly Sweepstakes entries received during the Promotion Period will be automatically entered into the Grand Prize Sweepstakes drawing.** Registration and entry into the Sweepstakes is free.
2. **ELIGIBILITY:** Open to legal residents of the states of Alaska, Alabama, Arkansas, California, Florida, Georgia, Hawaii, Kentucky, Louisiana, select Missouri counties (including counties: Bollinger, Butler, Cape Girardeau, Carter, Dunklin, Iron, Madison, Mississippi, New Madrid, Oregon, Pemiscot, Perry, Reynolds, Ripley, St. Francois, St. Genevieve, Scott, Shannon, Stoddard and Wayne), Mississippi, North Carolina, South Carolina, Tennessee, Virginia and West Virginia who are 18 years of age or older at time of entry; and derive their primary source of income as a farmer. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical,

One (1) Grand-Prize winner will be randomly selected from all eligible entries received during the Promotion Period on or about 2/2/23 by Sponsor or its designee, whose decisions are final. Potential winners will be contacted by Sponsor or its designee by phone, mail and/or email, at Sponsor's discretion.
5. PRIZES/APPROXIMATE RETAIL VALUES (ARV)/ODDS: One (1) Grand Prize is available. Grand prizewinner will receive \$5,000 in Corteva™ Cash. Seventeen (17) Weekly Prizes (one (1) Weekly prize each week of the Promotion Period) are available. Each Weekly prizewinner will receive \$500 in Corteva™ Cash. Corteva™ Cash is subject to the terms and conditions associated with its use. Corteva™ Cash will be deposited directly into each winner's Corteva account. Total ARV of all prizes \$8,500.
